Shihan Tomiyama's visit

In July 2024, Mr Keiji Tomiyama (Shihan, 9th Dan Tasshi Shito-ryu), President and Joint-Chief Instructor of Kofukan International, visited Australia again. Kofukan Karate Australia hosted a series of training seminars and classes, including open seminars on the weekend of 13th-14th of July. Karate-ka from all over the southern Perth and the Peel Region attended, along with people travelling from as far as Kalgoorlie, Geraldton, Manjimup and our own Dave Hatte from Hervey Bay, Queensland.

An unfortunate flight delay for Shihan Tomiyama meant Sensei Brian Chambers (6th Dan) delivered the seminars on Fighting Combinations and Shushi-no-kon (bo kata) on the Saturday.

Classes open to Kofukan members were held in the evenings on Monday at the Halls Head dojo and on Tuesday and Thursday at the Kwinana dojo. In addition, training for senior ranks was held during the day on Friday, Monday, Tuesday and Wednesday to practice high level kata.

The program also included social events: a black belt and committee member dinner on Saturday and a Kofukan Family Dinner on Sunday.

On Thursday 18th of July, a grading was held and Shihan Tomiyama passed Corey Parker and Brandon Didsman to 2nd Dan black belt.

Instructors and students learned a lot from Shihan Tomiyama's visit, as we always do. Thanks to everyone who took up the opportunity to train with Shihan Tomiyama and make the seminars a great success.

Panel gradings

Panel gradings are for students grading to senior ranks (those going for ranks of 2nd Kyu, 1st Kyu and 1st Dan black belt). Assessments are conducted before a panel of black belts from multiple dojos and the award of rank is certified by an instructor ranked 4th Dan or higher. Panel gradings were held in Perth and Kalgoorlie mid-year and end-of-year.

2024 saw us welcome four Senior Shodan black belts:

Kofukan Shito-ryu Invitational Development Tournament

On 15 September 2024, we hosted our annual Kofukan tournament at the Kwinana Recquatic Centre.

This year, the event was open to other clubs by invitation, and we were very pleased to get 110 competitors across kata and kumite events. Joining our members from across Perth, Peel and Goldfields regions were competitors from:

Our development tournament is a fun, informal and supportive environment for our members to gain confidence, overcome nerves and build competitive spirit. Many of our referees and judges are also developing in their roles.

The tournament held 14 kata events and 16 kumite events. During the lunchtime break we also put on some fun activities – board breaking and a high cliff jump.

Fundraising

In 2024, Kofukan Karate Australia completed three rounds of a new fundraising competition which encourages donations through Containers for Change.

The Containers for Community Karate competition was the brainchild of Chairperson, Don McKay and implemented by Secretary Lindon McKenna. By returning 100 or more containers through Containers for Change (WA) and donating the refund to Kofukan Karate Australia, anyone can go in the draw to win the equivalent of half of the donations in prize money.

In 2024:

- 11,483 containers were recycled by our members and community in our name, bringing in \$1,148.30 in donations (both as part of and separate to the competition).
- \$269.35 was awarded in prize money to competition winners: J Koenig, N Donnelly and M Gross.



Our other fundraising through the year was:

- \$470 from selling Cadbury Fundraising chocolates
- \$106 for the sale of raffle tickets and mouthguards at the Kofukan tournament
- \$100 from Grill'd as part of their Local Matters program
- \$71 from Tam Bakes Cakes as part of their Pay It Forward program
- \$12 from a raffle at the Wandi markets





Our fundraising revenue was used for:

- Subsidising the Kofukan tournament entry fee for members (\$5 off per competitor for 60 competitors)
- Subsidising WA Karate Federation tournaments (\$20 per competitor for two competitors)
- Buying equipment for dojos such as focus mitts and protective equipment (\$365.92)

Remaining fundraising revenue is being applied to long term goals of the Association.

Kofukan Karate Australia thanks all its volunteers and community members who were involved in our fundraising in 2024. A special thank you to Amanda Fellows, who organised our raffles and chocolate drive this year.

Members

Incorporation

Kofukan Karate Australia Inc. (the Association) was incorporated on 17 December 2021.

Meetings

The Association is required by its Rules to hold four management committee meetings each year. The management committee held four ordinary committee meetings in February, May, August and November 2024.

Committee

All committee positions are vacated automatically at each AGM. Accordingly, the reference period for meeting attendance in the table below refers to meetings between the AGM held on 3 March 2024 and the AGM held on 1 March 2025.

Sub-Committees

In May 2023, the management committee agreed to establish a sub-committee, called the Fundraising Committee.

The Fundraising Committee was not active in 2024.

Delegation

In May 2023, the management committee established the position of Tournament Manager as a subsidiary office under the Rules. The role of Tournament Manager is to manage and coordinate members' participation in non-Kofukan tournaments.

The Tournament Manager role was not required in 2024.

Technical Committee

The Technical Committee is established under the Rules and has responsibility for matters relating to the study of, and training in, Kofukan Shito-ryu Karate-do by members. All ordinary members (over 16 years) who have achieved the rank of 1st Dan black belt or higher are automatically members of the Technical Committee, with voting rights held by members ranked 2nd Dan and higher.

The Rules require the Technical Committee to hold at least three meetings each year. In 2024, the Technical Committee met three times, in April, August and December.

Staff

The Association is entirely run by volunteers and does not employee staff or contractors.

Treasurer's Report

I would like to take this opportunity to thank our Secretary, Lindon McKenna, who greatly supported me with settling into my role as Treasurer this year. It has been a pleasure working with you to plan and finalise events for our community.

I would also like to thank everyone who assisted with the organising and roll-out of our fundraising activities. Thanks to you, with the support of our community, we raised funds to purchase equipment and subsidise tournament entry fees for our members.

Our financial statements show that we made an increased profit from last year. This, in part, is due to our cash basis method of accounting. This means we account for our income and expenses as we receive and pay for them in our bank account. For example, we received a grant payment from the City of Kalgoorlie-Boulder in January 2024 for our anti-bullying workshop held in October 2023.

Changes that significantly affected our profit and loss statement this year are:

- Reduced membership. While this means reduced member fees, it also means that some expenses like our Kofukan International Membership fee is also reduced;
- Increases in Shihan Tomiyama's travel and teaching fees;
- Reduced venue hire costs for Shihan Tomiyama workshops due to City of Mandurah refunded venue hire;
- Increased insurance costs due to change in provider. This ensures that our Association and its members continue to have appropriate coverage for all of its activities;
- Grant received from the City of Kalgoorlie-Boulder for the 2023 anti-bullying workshop was paid in January 2024;
- Increased black belt grading expense due to delayed payment for 2023 gradings;
- Reduced WAKF tournament expenses due to changes in WAKF's registration processes. In 2024 these changes allowed for individual competitors to register themselves instead of requiring the Association to do it on the individual's behalf;
- Reduced 2024 Kofukan Karate Australia tournament expenses due to a bulk medal order in 2023;
- Mandurah grading and Other expenses that related to 2023 end of year events for our Association, were not repeated in 2024.

Thank you to the instructors who trialled the merchandise ordering process. This should lead to a smooth roll-out of our merchandise sales to our members in 2025.

I am looking forward to continuing to work with the committee and our members as we move forward into 2025.
